THE ACTION: Kyung Soon, a sophisticated Korean woman, appears to exert undue influence in obtaining priority medical attention for a child. Thus, when Potter orders Hawkeye to go with her to attend to Kyung Soon's ill mother, Hawkeye makes no attempt to contain his sarcasm. However, upon reaching the bombed-out estate and seeing the effort Kyung Soon has put forth into caring for numerous homeless peasants, Hawkeye's attitude changes. Gradually, their mutual interests and attraction lead to love. The morning after their picnic date at a bombed-out restaurant, Hawkeye and Kyung Soon say a reluctant goodbye in her bedroom. He tells her he'll be back as soon as he can. Hawkeye is in the operating room when a boy from Kyung Soon's estate comes by asking him to come see her mother. By the time Hawkeye arrives, the old woman is dead. After the funeral, Kyung Soon tells Hawkeye that she must leave Oui Jung Bu. She explains that she only stayed out of respect for her mother. Hawkeye has a difficult time accepting this, but in the end he lets her go.
